Alex Rivera is the director of the Center for Economic and Workforce Development, Social Entrepreneurship and Innovation at the John S. Watson Institute for Urban Policy and Research at Kean University. He supports New Jersey communities in providing for the economic needs of people in socially equitable and environmentally sustainable ways.

In collaboration and partnership with fellow colleagues from the John S. Watson Institute for Urban Policy and Research, Ana I. Berdecia, M.Ed., director for the Center for Positive Development of Urban Children, and Kean University Equity in Action Presidential Postdoctoral Fellow Saran Nurse, Ph.D., from the College of Business and Public Management, Rivera and team were awarded a \$40,000 grant from Bank of America to link family childcare provider educational quality and business development. This initiative aims to help family childcare providers enhance educational quality and business viability by providing technical assistance and consultancy for providing culturally competent and responsive education and business development support in underserved communities.

This grant will be instrumental in developing a program that provides entrepreneurial childcare providers with highly valuable skills to help their businesses thrive while maintaining a safe and healthy environment for children. It will have a ripple effect of

strengthening the local economy and of parents having the freedom and confidence to maintain their own employment.

"The work that the Kean University Foundation is doing to provide programs and initiatives that support family childcare providers in New Jersey is crucial," said Alberto Garofalo, president of Bank of America New Jersey. The Cougar pride was fierce and the lawn was full as 4,000 people were in attendance – doubling the number of guests at the previous year's festival. There were also a number of food trucks and vendors located around the perimeter of the festival as well, where guests could grab some food and Kean gear, or visit the wellness tents.

#### Student Spotlight: Dean Schirripa

Dean Schirripa arrived at Kean University in the Fall of 2021 as a transfer student. He took the initiative to compare different colleges and universities based on their curriculum, location, transfer equivalency and affordability. After further review, Dean decided to attend

Kean because it was one of the first teaching colleges in New Jersey.

When he enrolled, he applied for scholarships and was fortunate to qualify for and receive The Harold B. and Dorothy A. Snyder Foundation scholarship which focuses on the fields of healthcare, education, social service and faith. "Kean afforded me the most flexibility with the highest access to quality education and I am thankful for the scholarship and the services provided for me," said Dean.

When he enrolled at Kean, Dean made a promise to himself that he would find ways to push through the challenges he would face, especially since he would be balancing both work and school. He strategically scheduled his classes and balanced course options by levels of difficulty. For example, he does best when mixing freshman, sophomore and junior classes each semester so he can absorb the information more effectively while maintaining his GPA and easing mental fatigue. It's a strategy that he's found most helpful.

Dean has also learned to schedule his courses with breaks built into the days. Scheduling his courses in this manner has afforded him the time for self-care, study and even participate in some extracurricular activities. He has become involved in the Earth Science Club and hopes to join the ASL (American Sign Language) Club, as well as the Tomorrow's Teachers Club for aspiring educators.

Dean has already taken courses in ASL and it has been an experience that has very much resonated with him. He has also enjoyed his psychology courses, particularly child psychology, and is considering taking a course in the psychology of learning. Since arriving at Kean, he has appreciated the passion and dedication each faculty member has for their subject. Dean has been amazed at how his professors have been able to formulate their subject and their ability to make the lessons and coursework relatable and exciting.

Ever since Dean's initial campus tour, he has had a welcoming experience at Kean University. He noted that Dr. Kim-Le Downes' transfer transitions course was incredibly helpful and both Drs. Barbara Lee and Joseph Sarnoski have been informative and accommodating. "They've helped to expand my perspective and thinking about different courses and have given me a stronger appreciation for a wide variety of disciplines," said Dean.

With passion, dedication and a flexible mind, Dean hopes to continue to work toward his degree to become an educator and give back to his future students.

## Year-End Giving!

# Consider some ways to invest wisely at calendar year-end.

- Benefit from a charitable income-tax deduction: Individuals who itemize may deduct 2022 gifts up to 60% of their adjusted gross income (AGI) for charitable contributions. If your contributions exceed the deduction limit, the amount of the excess contributions can be carried forward over the next five years.
- Give all or part of a required minimum Individual Retirement Arrangements (IRA) distribution: An individual over age 70 1/2 is permitted to make a transfer directly from their IRA custodian to a qualified charity, like the Kean University Foundation. The amount transferred is then not included as taxable income and will count toward the required minimum distribution (RDM).
- Avoid capital gains tax: Individuals who contribute appreciated stock avoid incurring capital gains tax on the appreciation.
