#### Hello Friends,

This annual report provides us with the opportunity to reflect on the Kean community's achievements and the tremendous growth of our world-class University.

Our students, faculty, and staff continue to excel—many of them on a national scale. Dr. Patricia Morreale, head of the University's computer science program, for example, joined the ranks of Nobel laureates and science pioneers as a fellow of the American Association for the Advancement of Science. Four women of color, who graduated with mathematical sciences degrees in May 2019, were accepted to some of the nation's most prestigious graduate programs in mathematics, bucking a trend showing both gender and racial gaps in this field in higher education and professions. Our first students enrolled in the architectural studies program at Kean also earned their undergraduate degrees in 2019, realizing the dream of their patron, the late Michael Graves, to bring more women and minorities into this field.

With the support of alumni and other friends, Kean has always dedicated itself to providing the opportunity for all students to receive a world-class education. As part of that mission, we continue to engage our students in valuable research opportunities. This year, more than 1,400 students took part in our annual Research Days event to showcase their original research at Kean USA and Wenzhou-Kean University. That's 15-times the number of participants from when we started this program 10 years ago. Our new Kean Quest peer-reviewed research journal also debuted this year. Clearly, we're on the right track.

Kean continues to expand its physical footprint, as well. This fall, we're opening the Kean Skylands campus on a rural property located in Jefferson Township. The campus will offer degree-completion programs in a renovated former abbey and "treehouse" classroom building, complete with a "skywalk" elevated walkway to take in the natural beauty of the New Jersey Highlands. Our degree-completion programs at Kean Ocean have also expanded to the Southern Education Center in Manahawkin, ensuring a Kean degree is easily accessible in all parts of New Jersey.

Those of you who have recently visited our Union campus recently know that construction is well underway for Hynes Hall, the new home of the College of Business and Public Management, made possible with generous support from Jim Hynes, a 1963 Kean graduate, and his wife, Carole. The amazing state-of-the-art building is set to open in 2020.

Further down Morris Avenue, the new Liberty Hall Academic Center will soon become New Jersey's only public center for history and education.

Our Wenzhou-Kean University campus is thriving, as well. A new building for Michael Graves College will open in 2020 as we prepare to welcome 2,400 students across the WKU community.

Kean continues to focus first and foremost on student success. In the past year, we joined International Studies with Career Services and invested in new full-time staff to provide students with experiential learning. We are delivering on our promise to provide every interested student with an internship before they graduate. Our newly renovated Center for Academic Success also opened this Fall, providing a One-Stop Service Center to assist students with registration and other needs. The new space also houses a robust advising center for our freshmen.

As the University grows, we continue to support the students who need us most. Our Foundation, the philanthropic arm of the University, is growing and redoubling its commitment to our student body and alumni. Under the leadership and direction of our new Chief Executive Officer, Bill Miller, the Foundation is on track to have its best year since 2010.

#### A few highlights:

- Overall, the Foundation awarded more than \$800,000 in scholarship support over the past year. Without that funding, many of our students would be unable to achieve their goals of graduating from an institution of higher education.
- We recently launched the Centennial Scholarship Fund to assist the highest-achieving students with additional expenses after all other grants and scholarships have been exhausted. This new fund is a game changer for students from economically disadvantaged backgrounds.
- This year, the average gift from our generous donors is nearly \$2,000. This far exceeds the sector benchmark of \$516.



Despite 2018 being a volatile year in global equity markets, Kean's main endowment portfolio has continued to outperform and returned 8 percent year-to-date.

The impact of your generosity transforms thousands of lives.

The Foundation is in the process of restructuring and the goal is to bring you a highly talented and experienced team of professionals and a practical plan for growth and success we can all share.

This spring we had the chance to celebrate with our students at their commencement ceremonies. We recognized the first class of undergraduate architectural studies graduates and the first classes of doctoral graduates for both the speech-language pathology and physical therapy programs. It is striking how far Newark State Teachers College has traveled to become Kean University; it is even more striking how far our students have come to achieve their dreams.

We look forward to working with our Foundation Board and others to provide even more support for our students in the year to come. They deserve it.

- Our people are passionate about providing help to our campus community, and our commitment is total.









## 2019 Highlights, News & Milestones

#### Welcoming Our Inaugural Centennial Scholars

More than 50 freshmen began their college careers at Kean University this fall as the recipients of a bold new scholarship initiative designed to provide some of the region's brightest, but financially challenged, students with access to the dream of higher education. These students are recipients of the new Centennial Opportunity Fund Scholarship, which was envisioned and created by Kean President Dawood Farahi, Ph.D., with the support of the Kean University Board of Trustees and hundreds of Kean donors.

President Farahi said the new scholarship initiative was inspired by a combination of research and interaction with a variety of current Kean students and local high school students.




"Excellence and equity are reflected in all aspects of university operations, from the policies of the Board of Trustees, to the strategic plans that have been implemented, to administrative actions taken at all levels," Farahi said. "They require each one of us to go the extra mile for our students and our potential students. Excellence is translated into our vision for a world-class education, but equity is the other key pillar of Kean's mission: we must provide students with the tools they need to be successful."

The Centennial Opportunity Fund Scholarship is now a powerful tool in that arsenal. "The Centennial Fund is definitely taking a load off my shoulders. The help is really making me want to pursue my dreams," said Emiliana Robinson, a freshman recipient who plans to major in interior design. "And it's not just me; my family is really happy, too, because I have three younger brothers who are going to be going to college after me, so getting this scholarship meant a lot to all of us." Marsha McCarthy, vice president of Enrollment Services at Kean, said the first pool of applicants for the scholarship were both academically and individually strong. Many of the final award recipients said the scholarship made the difference between deciding to go to college and postponing that decision because of financial challenges. In its inaugural year, 54 students were provided with the Centennial scholarship, and two-thirds of these students were women and minorities. The average adjusted gross income (AGI) of this first class of recipients was \$39,408 and the average amount of scholarship funds was about \$2,630—enough to close the gap between traditional federal and state grants and required out-of-pocket contributions. Once fully operational, President Farahi said the fund could support about 300 students per year.

"This relatively small amount of aid per student will make a huge difference in their individual lives," he said.

Farahi said the goal is to create a \$30 million endowed fund that generates the income needed to fund these scholarships on an annual basis. Already, many Kean alumni, friends, and benefactors have allocated or pledged \$17 million to the fund, and the President said he will reach the \$30 million goal in 2020.

"It must happen and it will happen," he said.



## Building for the Business Leaders of Tomorrow – The New Hynes Hall

Today's global economy requires business leaders who are agile and well-informed, who understand not only the bottom line, but also how the cultures, practices, and challenges of operating in an international environment shape that bottom line.

"The global economy drives all that we do —from education to manufacturing to investing—and it's our responsibility to ensure that Kean students are learning the skills they need to thrive in that economy," said Kean University President Dawood Farahi, Ph.D. "We have the foundation already; now the timing, the location, and the funding are in place to put the new academic business building on the map."

President Farahi says enrollment in Kean's business programs has outpaced enrollment in many other programs at Kean. Today, more than 4,800 students are pursuing business degrees through Kean's business program at both the undergraduate and graduate level.

"Our business and public management programs are growing exponentially, and the quality of our programming surpasses the competition," says President Farahi. "Now, we need to provide the facilities to raise these programs to the next level. Our students are excited, our faculty are excited, and our community is excited to see this new facility take its place at Kean USA." Kean alumni are thrilled as well, particularly Jim Hynes, a 1963 Kean graduate whose tremendous success in business, and in life, are matched only by the magnitude of his generosity. In late fall of 2018, Hynes, along with his wife, Carole, announced a significant contribution towards the development of the Global Business School's new academic facility. In recognition of their generous gift, the University has announced the spectacular new building will carry the name Hynes Hall.

"I want to give back," Hynes said. "It's that simple. I am so driven to pay back to a school that gave me a chance."

The 90,000-square-foot Hynes Hall will house all of Kean's undergraduate and graduate business programs, as well as a wide variety of state-of-the-art resources, including smart classrooms and study lounges, a "Bloomberg room", where students can work with Bloomberg business intelligence software, a virtual "library in the sky", and a rooftop deck with a view of New York City.

David Farrokh, Assistant Dean of the College of Business and Public Management, notes how the new facility will better prepare students to become business and public management professionals by simulating the modern business environment. "It underscores President Farahi's vision for an enhanced student experience and will allow us to supplement the classroom experience with experiential types of learning," Farrokh said.

#### Kean Alumni Named New Principal at Triangle Elementary School

Anthony Aliperti has been selected as the new principal of Triangle Elementary School in Hillsborough, New Jersey, effective August 11, 2019.

Aliperti was approved with a unanimous vote at the June 10th meeting of the Hillsborough Board of Education. Since 2015, Aliperti has served as assistant principal of Ethel McKnight Elementary School, a kindergarten-through-second-grade school in the East Windsor School District.

Aliperti began his career in education in the Branchburg Township School District as a third-grade teacher. During the 2008-2009 school year, he was honored with the District's Teacher of the Year award. In addition, he served as the Branchburg District's testing coordinator during the 2013-2014 school year. Aliperti has also worked as a special education early intervention specialist with the Matheny Medical and Educational Center.

He received his bachelor's degree in elementary education from Kean University, holds a master's degree in special education from Centenary University, and a master's in administration and leadership from Georgian Court University.

"I believe all children can learn and be successful," said Aliperti. "I will be devoted and dedicated to the students, families, and staff of Triangle Elementary School as we work collaboratively to instill a love of learning in our children and enrich young lives."

"We are pleased to welcome Mr. Aliperti to Hillsborough," said Jorden Schiff, superintendent of Hillsborough Schools. "His extensive background in elementary education and commitment to cultivating a collaborative and supportive learning environment for students and staff will serve the Triangle School community well."

#### Kean Industrial Design Grad Wins Top National Award

Recent Kean industrial design graduate Emma Mantell '19 is one of five regional winners of the Industrial Design Society of America (IDSA) Student Merit Award, the highest national student award of the professional organization.

"This is the most prestigious award in the U.S. for a student, the institution, and the faculty in the industrial design field. Almost all of the previous winners' careers skyrocketed after this event," said Efecem Kutuk, assistant professor and program coordinator of industrial design at the Robert



Busch School of Design in Michael Graves College. "We are very proud of Emma and hope her success will serve as a model for other students in the college."

Mantell was inspired to create the two-part winning design, to some degree, by her grandmother's accessibility challenges as she aged. One project, called esa, uses technology to design a door lock, door handle, and key chain to assist the elderly and those with motor skills limitations. The other, called Prana, is a breast shield device and app that measures milk flow from nursing mothers to their babies.

"This is an incredibly prestigious award, and I'm incredibly honored," Mantell said. She said both projects were conceptualized in class, designed to meet users' needs, and guided by professors.

The name of the first project, esa, stands for "ease, style, and accessibility." The other, Prana, is named for a Buddhist hand gesture

that represents life-giving energy. "It's something I thought relates perfectly to nursing," Mantell said.

Mantell, who is from Vernon, New Jersey, will present at the International Design Conference taking place in Chicago this August. There she will have the chance to network with more than 400 professionals. Her name will also be featured on the IDSA's website for years to come.

Kutuk, who taught Mantell almost every semester while at Kean, said she worked hard, took feedback, and exceeded standards throughout her education.

"Both projects can be considered technological designs for the social

good; not just beautiful, meaningless objects, but problem-solving ones," he said.

Mantell said she looks forward to presenting at the conference and pursuing her career goals. She said she chose to attend Kean because she wanted smaller classes and opportunities to be involved with other design students, as well as taking advantage of the campus' access to New York City.

Mantell chose industrial design because she felt it integrated aspects of both art and science that she enjoyed. Mantell said she ultimately hopes to work in an environment with "plenty of variety and collaboration."

"A job that would allow me to meet and work alongside lots of new people would be ideal for helping me to build a greater perspective that will aid me in growing as a designer," she said. "Honestly, my career goals are constantly evolving."

*Wind Over Stones* is a collection of forty ekphrastic prose poems and descriptions of the paintings that inspired them. A unique additional feature of the book is the inclusion of QR codes, allowing readers to access images of referenced paintings while they are reading. This interactive element affords readers the ability to enjoy a multi-dimensional experience and can be accessed via smart phones with built-in cameras or free QR code readers.

#### Kean Alumna Publishes Memoir, Goat in the Attic

Sophie Stach Virgilio '61 recently published her memoir, *Goat in the Attic*, a young girl's memories of Hitler's occupation of Poland. Sophie was almost a year old when Hitler invaded Poland in September of 1939, and she lived with her family on a farm in Godowa, Poland, during Hitler's occupation.

Sophie's stories are both jarring and joyous, answering the question "What was daily life like during one of the most volatile times and places in history?" Her work has been recognized by New Jersey Governor, Philip D. Murphy, and by U.S. Congressman, Christopher H. Smith.




