- If **5 faculty/staff** give **\$2,500**, one student can attend Kean.
- If **4 faculty/staff** give **\$500**, one freshman student can purchase their meal plan.
- If **4 faculty/staff** give **\$250**, one student can purchase their books and supplies.
- If **4 faculty/staff** give **\$50**, one student can apply for their Student Teaching Fee.

As you can see, with each gift received, one more Kean student can excel in their college career.
